When children with Medicaid transition to Medallion 4 and anytime their MCO changes, a new assignment of benefits with the name of the MCO must be completed and signed. This is also a requirement for children with CCC Plus. The third page of the cost share or an agency form can be used.

PROVIDER IMPLEMENTATION SURVEY COMING SOON!

As part of our State Systemic Improvement Plan (SSIP), Virginia is implementing an annual Provider Implementation Survey. **The third annual survey will be coming in October**. By completing the survey, you will help the Infant & Toddler Connection of Virginia:

- Understand how evidence-based practices are being used in Virginia;
- Ensure you have the resources and supports you need to implement these practices; and
- Evaluate our statewide improvement efforts to improve outcomes for infants, toddlers and their families.

Higher provider participation will yield more complete and helpful data for use at the state and local level, allowing us to invest future time and effort into activities and supports that providers find helpful and set aside any that are not effective. In order to emphasize the value of provider participation in this survey, those who complete the survey will receive ½-hour of professional development credit toward the 30 hours required for renewing your early intervention certification.

All survey responses are confidential and no information that could identify you will be linked to your individual responses or shared publicly or with any directors, supervisors, the local system manager, or other personnel in your local early intervention system or your program/agency.

PRACTICE MANUAL REVISIONS:

Revisions have been made in five Practice Manual chapters. Those revised chapters will soon be posted to the Infant & Toddler Connection of Virginia website (www.infantva.org). Changes include the following:

- Chapter 3, page 6 Clarified the late referral timeline that allows the local early intervention system to refer the child directly to the local school division to avoid confusion with federal regulations and timelines detailed elsewhere in the practice manual.
- Chapter 6, page 7 Specified expectations associated with required use of the Decision Tree.
- Chapter 7, Instructions for Completing the IFSP, Section VII Moved details regarding transition activities to Chapter 8
- Chapter 8
 - Pages 26 36: Combined transition information from Chapters 7 and 8
 - Page 37 38: Specified expectations associated with required use of the Decision Tree at exit

- Page 43: Added the timelines to follow if a child's EI benefit is dropped in the Medicaid VaMMIS system, consistent with what is already specified in Section 3.1.3 of the Local Contract
- Chapter 11, pages 8, 30-31 Added the timelines to follow if a child's EI benefit is dropped in the Medicaid VaMMIS system, consistent with what is already specified in Section 3.1.3 of the Local Contract.

THE DECISION TREE

In Virginia, we have long recommended use of the Decision Tree to assist in determining child outcome ratings. Virginia is now requiring use of the Decision Tree when determining initial, annual and exit ratings.

Feedback from the Provider Implementation Survey and the MEISR pilot indicate that the Decision Tree is a key tool in the effort to have accurate ratings and inter-rater reliability. Accurate child outcome data is essential for federal reporting, for state and local improvement planning and for assessing child progress over time. The Decision Tree is also a helpful tool in supporting active family engagement in the functional assessment and child outcome rating process. Since families are equal team members, it is appropriate and respectful that they are included in the process of team discussion and decisions about how their child's functioning in the three outcome areas compares to same age peers and that they can see the Decision Tree we're using to make that decision.

Revisions in Chapters 6 and 8 of the Practice Manual provide more information about the required use of the Decision Tree. We recognize that this will be a change for many assessment teams and that engaging families in this process may be more challenging and/or more uncomfortable in some situations than others. Given that one of the purposes of early intervention (see Chapter 1 of the Practice Manual) is to enable families to provide care for their children and that one of the family outcomes we measure is the extent to which early intervention helps families effectively communicate their children's needs, working through the initial learning curve and perhaps our own discomfort to fully engage families in using the decision tree with us is a worthwhile effort. There are a number of resources available now and coming soon to support assessment teams as they implement this new requirement for using the Decision Tree.

- The nationally-developed COS Team Collaboration Toolkit, available at
 http://olms.cte.jhu.edu/olms2/COSTC, includes information about and videos illustrating ways to
 explain to and engage families in the outcome rating process using the Decision Tree.
- A short tutorial about using the Decision Tree is being developed at the state level and will be available soon.
- The November and December Talks on Tuesdays will focus on the Decision Tree and engaging families in the child outcome summary and rating process using the Decision Tree.
