The most bothersome issue is the fact that children have to go through a reassessment to determine if they are still eligible for waivers.

*My name is Sandi Harrington. I'm the Local System Manager for the Infant & Toddler Connection of Norfolk. Today, I am here representing CoCoA Steering Committee. We would like to thank the Part C office and DMAS for their collaboration which has put our Early Intervention programs ahead of so many other programs affected by CCC+. The trainings, lists of children, and questions that are quickly*

*answered have been extremely helpful. Although we have made progress, the true impact of CCC+ on the Early Intervention system will not be realized until the end of the continuity of care period. Issues to watch include timely payment, in network provider availability, contract finalization, and the impact of provider choice on the system's finances.*

## **AGENCY REPORTS**

### **The Arc of Virginia, New Path Program-Tracy Edman**

The 2017 State Convention was held August 7-9th at the Hilton's THE MAIN Hotel in Norfolk, VA. There were sessions geared toward younger families. The conference also provided attendees with latest information on federal and state issues affecting Virginians with developmental disabilities and their families. The conference also included sessions on Waiver Redesign, Commonwealth Coordinated Care Plus, Federal Policy Issues, Inclusive Education and Early Intervention.

Guest speakers included Mrs. Pam Northam, Second Lady of Virginia (on behalf of Lt. Governor Ralph Northam, Candidate for Governor), Ed Gillespie, Paul Ryan, and Attorney General Mark Herring, Candidate for Attorney General of Virginia. There were about 400 participants.

### [Virginia Department for the Blind and Vision Impaired \(VDBVI\)-Tracey DeLuca](#)

The Department for the Blind and Vision Impaired (DBVI) has distributed over 30 sensory exploration quilts across the state. The quilts are a solid color on one side and blocks of colors and textures on the other side. They were given to families that have children with vision impairments. These quilts use different fabrics for textures, raised decorations and other accessories that encourage the quilt's user to feel and grasp.

The VDBVI will be hosting a Friends and Family Day Event, to be held October 21, 2017. This event is for anyone who is blind or vision impaired or who has a family member experiencing vision loss, and is always an exciting opportunity for making connections and building networks. The theme this year is "Demystifying Independence," and there will be activities to help participants explore strategies for working and doing everyday tasks as a blind person. We also want family members and friends to know how they can help in promoting and supporting their loved ones who are using their skills of independence at home and in the community.

### [Virginia Department for the Deaf and Hard of Hearing \(VDDHH\) -Eric Raff](#)

The Virginia Department for the Deaf and Hard of Hearing held an open house two weeks ago to celebrate their 45th Anniversary. There was a great turnout. The Virginia School for the Deaf and Blind has just opened independent living apartments in Staunton, VA to teach independent living skills to young adults who just graduated from high school. There are currently five apartments available.

The VDDHH has hired a new staff member, a Community Services Specialist. One of their first assignments was to develop a statewide resource staff directory. If you know of any experts that provide services specifically for the deaf and hard of hearing, please feel free to forward that information to Eric Raff so that it can be added to the directory. The goal is to have this list published by next year.

**The following update is a written report provided by Dr. Bethany Geldmaker.**

1. Fall 2017: Reminder flu vaccines, handwashing, cleaning and sanitizing practices
2. First aid flip charts newly revised- if interested feel free to pick up one before you leave
3. Infectious disease update: Vibrio infections
  - a. The *Vibrio* species that cause vibriosis naturally live in the salt or brackish (i.e., somewhat salty) waters of Virginia's coastal zone. People with vibriosis become infected by eating raw or undercooked seafood or exposing a wound to seawater. Most infections occur from May through October when water temperatures are warmer. *Vibrio vulnificus*, in particular, can cause severe or fatal infections. Individuals with pre-existing medical conditions such as liver disease, diabetes, HIV, cancer, and certain stomach disorders are at greater risk of becoming sick with vibriosis and experiencing severe complications.
  - b. Helpful tips for preventing Vibrio infection:
    - i. Eat cooked seafood
    - ii. Avoid contact with seawater or preparing raw seafood such as oysters and shrimp if you have an open wound, even if it's a minor cut or scrape. Or cover your wound with a waterproof bandage.
    - iii. Wash wounds and cuts with soap and clean water if they have been exposed to seawater, raw seafood, or juices from seafood.

- a. The CDC has released the recommended Immunization Schedules for 2017. They are designed in an easy-to-read, full-color format available in English and Spanish. They are a perfect informational handout for patients and parents.

- c. The comprehensive summary of the ACIP recommended changes made to the schedule can be found in the MMWR.
- d. Changes to the schedule include:
  - i. Hepatitis B vaccine (Updated 3/6/2017) collapsed
  - ii. Polio vaccine (New 2/17/2017) collapsed
  - iii. Medical Conditions collapsed
  - iv. Diphtheria and tetanus toxoids and acellular pertussis vaccine collapsed
  - v. Haemophilus influenzae type B vaccine collapsed
  - vi. Human papillomavirus vaccine collapsed
  - vii. Influenza vaccine collapsed
  - viii. Meningococcal vaccine collapsed
  - ix. Pneumococcal vaccine

### 7. Children are still being exposed to lead( [www.childtrends.org](http://www.childtrends.org) and <http://www.vdh.virginia.gov/>)

- a. Even today, exposure among children comes from a variety of sources, especially from deteriorating lead-based paint in older buildings, lead in pipes that deliver drinking water to homes and schools, or residential proximity to airports used by planes that still

run on leaded fuel. Exposure to lead can even come from food, candy, and other consumer products. The [neurological effects](#) of lead exposure can be devastating. In children, it is associated with [academic and behavioral struggles](#) in school, as lead makes it more difficult to concentrate in class and increases the likelihood of diagnosis with learning disabilities. These deficits become risk factors for future [negative outcomes](#)--including delinquency, criminal behavior, substance use, and teen pregnancy--as exposed children enter adolescence and young adulthood. Some of these negative effects may be offset by high-quality programs provided in early and middle childhood, but the preferred solution by far is to prevent initial exposure to lead.

- b. Federal, state, and local policymakers need to adhere to evidence-based recommendations for dealing with lead hazards to prevent exposure among children. Recommendations with the potential to impact the most children include the following:
- i. Reduce lead in drinking water in homes built before 1986 and in other places that children frequent, including child care settings and schools.
  - ii. Remove lead paint hazards from housing built before 1960, especially in low-income housing, and in other places where children spend time.
  - iii. Increase enforcement of the EPA's renovation, repair, and painting rule to ensure that the appropriate safety measures are taken when work is done in a house with lead paint.
- Recommendations for policymakers to respond on behalf of children who have already been exposed to lead:
- iv. Improve blood lead testing among children at high risk of exposure, and find and remediate the sources of their exposure.
  - v. Ensure access to developmental and neuropsychological assessments and appropriate high-quality programs for children with elevated blood lead levels.

### [Virginia Department of Medical Assistance Services \(DMAS\)-Jeanette Abelson](#)

Jeanette informed the VICC that Town Halls are going to be in Northern Virginia region next. All of the Town Hall information is listed on the DMAS website. Additionally, Jeanette along with other EI Specialist will be attending the Winchester Medical Center for the Services Coordination and Care Coordination Collaborative meeting as we try to figure out what we need to work on in that area.

DMAS will be fully integrated with CCC+ as of January 1, 2018. A stakeholders meeting was held a few days ago where management talked about the top five CCC+ difficulties and are working on a game plan to address those issues.

### [Virginia Department of Social Services - Aleta Lawson](#)

The Virginia Department of Social Services is preparing for their biggest initiative. The Head Start Collaboration office will be funding a statewide Trauma Informed Care Initiative for all children but, especially at risk children. The Head Start Collaboration office will be partnering with John Richardson-Lauve. John is the Director of Mental Health and Lead Trauma and Resilience Educator at ChildSavers. This will be a multi prong approach starting with training the Directors of Head Start across the state.

The next step will be our 2017 Health & Family Services Institute for Head Start Directors, Health Managers and Family Services Staff. Head Start adopts the “it takes a village approach” for offering comprehensive services to children and families. Much of our support covers a large scope of issues that can be quite wide-ranging. Head Start staff wear many hats, and often our roles overlap, to create a collaborative effort with the family’s goals in mind. Therefore our annual Health Institute also includes workshops designed for Family Services Staff to help foster this collaborative approach. This year's conference will be held November 15-17, 2017 at the Stonewall Jackson Hotel in Staunton, VA.

The next step will be to have four regional trainings across the state to train the Head Start staff. Then we will have a training of the trainers, where we will train the Head Start Collaboration office staff to become trainers. The final phase in this project is to have a training or retreat for parents.
