INFORMATION TECHNOLOGY (IT) CORNER

ITOTS 1.8

Technical issues continue to delay user acceptance testing of this release of ITOTS. We are working closely with VITA to resolve these issues. If you or someone at your location is interested in testing, please contact David Mills.

ITOTS Expansion

A new procedure is in place where the Secretary of Health and Human Services must approve all IT projects. Because this project had not been presented to the Secretary previously, we are doing so at this point. Hiring contractors for this project has been put on hold pending approval from the Secretary. We hope to receive his approval before the end of this month.

COMPREHENSIVE SYSTEM OF PERSONNEL DEVELOPMENT (CSPD)

Kaleidoscope: New Perspectives in Service Coordination, Level I and Level II

Two Kaleidoscope, Level I trainings are scheduled for this fall. The first training will be held in Norfolk on September 16th and 17th. The second training will be held in Fairfax on October 25th and 26th. Training times are from 8:30 a.m.-4:30 p.m. each day. A Kaleidoscope Train-the-Trainer event will take place on August 20th in Fishersville. Eighteen service coordinators will gather to learn more about adult learning, the history of Virginia's service coordination training, and plans for next steps with the curricula. Following the training, it is hoped that there will be an expanded pool of Kaleidoscope trainers.

Professional Development and ARRA Funding

American Recovery and Reinvestment Act (ARRA) grant funding has been designated for professional development. The grant has additional professional development deliverables for a two year period. Dana Childress, former LSM in Chesapeake, has been hired as the Program Specialist in Early Intervention through this grant. In addition, recruitment is now underway to hire a technology specialist to assist with distance learning activities. Sue Murdock, Ph.D., is serving as the project's evaluator and Deana Buck is the Project Director.

The Integrated Training Collaborative (ITC) will be the mechanism for professional development activities through this contract. Project staff met with the Part C staff in early July to frame a work plan for all ITC activities. The workplan will be posted on the Part C website and the training portal in the coming weeks. Updates on the project's work will be provided at VICC meetings, through the training portal (see below), and through Part C TA Updates.

Training Portal

A new training portal is being developed to "house" a multitude of new professional development activities. The portal will include links to the online credentialing modules, two modules on social-emotional development, and links to modules on inclusion and transition. Plans are underway for additional webinars and modules including topics on autism and the Family Cost Share. Additionally, as a follow up request from the Leadership Academy, "resource

landing pads” are being developed on transition, autism, cultural competence, and social-emotional development. These landing pads will include evidence-based research articles and books, links to ongoing blogs, and other additional resources. The portal will be available within the next few weeks. SpecialQuest Birth to Five Resource Materials

SpecialQuest (SQ) Birth to Five is a national effort that is designed to touch the “head, heart, and hands” of families and professionals working together to create inclusive communities for young children with disabilities. This relationship- and team-based approach enhances and sustains inclusive services, family leadership skills, and integrated, collaborative service delivery. The vision of SQ Birth to Five is that states and local communities, including Early Head Start and Head Start programs and their community partners, collaborate to provide high quality inclusive services for young children with disabilities and their families. This work is supported by embedding the SpecialQuest approach, materials, and resources into professional development and service systems.

Virginia received long-term technical assistance from SpecialQuest Birth to Five and the state’s Leadership Team continues to work to share the materials and approach with early childhood providers across the state.

The training materials are packaged in a Multimedia Library. SpecialQuest Birth to Five has agreed to provide a Multimedia Library for each local Part C system in Virginia. They will be distributed in the early fall.

ATTENTION PHYSICAL THERAPISTS:

Fairfax County Infant and Toddler Connection is considering hosting the course Screening for Medical Referral: the Pediatric Client. The cost for this course would be about \$170 (it typically is over \$400). It would be provided somewhere in the Northern Virginia region. The course is 2 full days.

In order for Fairfax to commit to sponsor the class they need to hear back from local system managers and physical therapists that they are interested in taking this course.

Virginia PT Licensees: Successful completion of the ACP course "Screening for Medical Referral: The Pediatric Client," comply with the Virginia State Requirement of "Evidence of 15 contact hours of continuing education in medical screening or differential diagnosis, including passage of a post-course examination." This will allow the physical therapist to apply for direct access in the State of Virginia.

Physical Therapy Direct Access:

The direct access law for physical therapy approved by the General Assembly in 2007 is now in place. Regulations have been adopted by the Board of Physical Therapy and to date about 200 physical therapists in Virginia have received their direct access certification allowing them to use the new portion of the law. - The one time evaluation after 3 years of practice has not changed. The PT can evaluate the patient and then contact the practitioner for a referral.
- A PT with direct access certification can evaluate and treat the child for 14 business days before obtaining the physician referral. The regulations state the following about the certification process for direct access: An applicant for certification to provide services to patients without a referral as specified in 54.1-3482.1 shall hold an active, unrestricted license as a physical therapist in Virginia and shall submit evidence satisfactory to the board that he has one of the following qualifications-

1) Completion of a doctor of physical therapy program approved by the APTA (specifically, the Commission on Accreditation in Physical Therapy Education, or

2) Completion of a transitional program in physical therapy as recognized by the board, or

3) At least three years of post-licensure, active practice with evidence of 15 contact hours of continuing education in medical screening or differential diagnosis, including passage of a post-course examination. The required continuing education shall be offered by a provider or sponsor listed as approved by the board... and may be face-to-face or on-line education courses.

- The ability to provide services without referral remains the same for the following groups under our current law: 1) a student athlete participating in a school-sponsored activity if the PT is an ATC or SCS, 2) [the] employees solely for the purposes of evaluation and consultation related to workplace ergonomics, 3) special education students under an IEP, and 4) the public for the purpose of health promotion and wellness, fitness, and health screening and prevention. A physical therapist will NOT need to apply for the certification process in order to continue using these aspects of our direct access law.

The Basics of Autism: A Training for Childcare Providers

Attached please find information and registration form for a Childcare Provider Workshop on the Basics of Autism to be held in Culpeper on October 9th. This workshop will also be replicated in Southwest VA in November and in Central VA next spring. It is a collaborative effort of Commonwealth Autism Service's Learning Institute and the Autism Action Groups across the state. This training will provide a comprehensive overview of autism for childcare providers. Participants will be introduced to the core deficits of autism, early warning signs, and common screening tools. Participants will also be provided with strategies to discuss concerns with family members. Evidence based interventions and strategies for successful inclusion in both the public and private childcare environment will be discussed. A Certificate of Attendance will be provided at the conclusion of the workshop.
