## In This Issue

### EARLY INTERVENTION TRANSITION TO MEDICAID MANAGED CARE COVERAGE

As the Early Intervention transition to Medicaid managed care continues the Department of Medical Assistance Services (DMAS - the state Medicaid agency), local systems, managed care entities, and the Infant & Toddler Connection (at the Dept. of Behavioral Health and Developmental Services- DBHDS) are working together to resolve problems. The workgroup is focusing on resolving issues in the following areas:

1. Provider enrollment and credentialing with the managed care entity
2. What needs to be included on the Individualized Family Service Plan (IFSP)
3. Submitting a correct (clean) claim
4. Correct reimbursement

If you have issues that you have been unable to resolve with the managed care entity, DMAS has two dedicated emails for questions and concerns.
